- Nullifying Congress Itself with 1000+ Signing Statements Deciding the

(Art. I, Sec. 1; Art. II, Sec. 1:7, Sec. 3)
- Stealing \$29,000,000,000 from the U.S. Treasury to bail out a sub-crime
mortgage trader (Art. I, Sec. 8: 2; Sec. 9:7)
