What We Want

3 Points — Preserve, Protect and Defend Our Constitution: Impeach the Bush Gang

- **We aim to impeach the Bush gang. It's our duty to do it today. Right now!** Along with thousands of patriots, we collect petitions for impeachment. Our country's going on five-million petitions signed! In all states more people disapprove the Bush gang than approve. You're in the majority — by a landslide. Throughout his presidency, Nixon did much better than Bush in the polls, and the threat of impeachment drove Nixon from power. The Democrats didn't force Nixon out, the American people did. Don't believe talk radio types who say impeachment is a waste of time. **YOU** make it happen when patriots join to demand justice. We call for impeachment because it's the right thing to do. That's what we tell our Congress and state legislature to do.
- **At the same time we're a national movement to get state legislatures to push** impeachment. Bless Tom Jefferson! Our state can initiate impeachment by transmitting to the US House of Representatives its petition to impeach. The *Jefferson Manual of Parliamentary Practices* is part of the House Rules, which govern the US House of Representatives. Section LIII, 603 states: "In the House there are various methods of setting an impeachment in motion: ...by charges transmitted from the legislature of a State (III, 2469).. ." General Assembly Assistant State Majority Leader Reed Gusciora wrote a draft resolution to impeach. **Twelve** states — California, Hawaii, Illinois, Maine, Minnesota, Missouri, New Hampshire, New Mexico, Texas, Vermont, Washington and Wisconsin — have introduced resolutions to impeach. **We can make this happen in New Jersey.** *The fact that success is not guaranteed does not relieve our state of its obligation to do all it can to defend the United States Constitution according to the oath of our state's officers.* Help our campaign to restore justice and reclaim democracy. Lobby with us in Trenton and in DC.
- **Justice is impossible when democracy's subverted, stolen and killed by criminals.** We work for justice because we know civilization is impossible without it. But impeaching the bad guys won't mean a thing when they control the voting process. There's no electric voting machine that can't be rigged. Computerized voting machines give paper receipts that "verify" your vote but **report your vote for the other candidate.** Gore was elected president by popular vote and in the electoral college. JFK was too. But Bush was literally "selected by theft then elected by theft."
Democracy's already stolen. Americans support the **VOTERS' BILL OF RIGHTS** for a national standard of *paper-only* balloting. We support the Voters' Bill of Rights. You should too. We must get rid of all voting machines in New Jersey **and** in our whole country. Hand counted paper ballots assure honest elections. You're entitled to democracy. Democracy is your birthright.
